Active Shooter Defined

One or more subjects who participate in a random or systematic shooting spree, demonstrating their intent to continuously harm others. The overriding objective of an active killer appears to be that of mass murder, rather than other criminal conduct such as robbery, hostage taking, etc. It also includes anyone who uses any other deadly weapon to systematically or randomly inflict death or serious bodily harm on others over a continuous or extended period of time.

What Columbine Taught Us




All law enforcement officers who may be first responders at a crisis, and all school resource officers, should be trained in concepts and skills of rapid emergency deployment, whether or not assigned as members of standing or reserve SWAT teams.

- 6:44 p.m.
 - Sulejman Talovic begins shooting spree in parking lot, shooting three, killing one
 - Moves into mall firing randomly
 - Enters Cabin Fever store, kills three, wounds one
 - Moves deeper into mall, shoots and kills one more
 - Off duty officer brings Talovic under fire

- 6:47 p.m.
 - Salt Lake City sergeant arrives and enters gun battle
 - Three additional officers arrive, flank, and challenge suspect
 - Suspect turns toward three officers
- 6:50 p.m.
 - Suspect is killed

- 1:50 p.m.
 - Police investigate suspicious death and missing victim car
- 3:11 p.m.
 - Police stop car driven by David W. Logsdon
 - Logsdon shoots at officer and officer returns fire; both are wounded
 - Officer takes two weapons from Logsdon before he escapes

Kansas City Mall

- 3:27 p.m.
 - Logsdon parks at Ward Parkway Shopping Center, gets out of car, and shoots two, killing them
 - Logsdon wounds another victim outside
 - Logsdon enters mall and randomly begins shooting at people
 - On-duty officer walking through mall engages and kills Logsdon
